Official Sweepstakes Rules

By entering this Sweepstakes, the entrant ("Entrant") agrees to be bound by these Official Sweepstakes Rules.

1. **Eligibility:** NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not improve chances of winning. Open to legal U.S. residents of Pennsylvania, New Jersey, and Delaware who are at least twenty-one (21) years of age at the time of entry and at the time that any Prize is redeemed. Officers, directors, managers and employees of *Philadelphia* magazine, www.phillymag.com and Metro Corp. (publisher of *Philadelphia* magazine and www.phillymag.com), Philadelphia Area Lexus Dealers Association, Toyota Motor Sales USA, Inc., and Team One Advertising (collectively "Sponsors"), and each of their respective parent companies, subsidiaries, affiliates, and related companies, dealers, advertising and promotion agencies, consultants and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, are not eligible to participate. 2. **How to Enter:** Follow all instructions in these Official Rules; otherwise entry may be disqualified. To enter the Lexus 'Ride In Style' Sweepstakes, visit www.phillymag.com/lexuswinefest, complete and submit the required information ("Entry"). All entries must be received between 10:00 A.M. Eastern Standard Time (EST) on March 28, 2019 and 11:59 PM EST on April 10, 2019 (the "Promotion Period"). Limit one Entry per person. Internet access and a valid email address are required to enter. Entries made through the internet are deemed to be made by the authorized account holder of the email address at the time of entry. Any attempt by any Entrant to obtain more than the stated number of allowed Entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant's entries and that Entrant may be disqualified. Duplicate entries will be voided. Entry will not be returned or acknowledged. Entrants must fully complete and submit all required data to be eligible; incomplete entries are null and void. Odds of winning depend on total number of qualified entries received during the Promotion Period. A Potential Winner will be notified by *Philadelphia* magazine via email on April 12, 2019. In the event that a Potential Winner's notification is undeliverable, a Potential Winner fails to respond to *Philadelphia* magazine after the fourth day following the first attempted notification, Potential Winner is deemed by Sponsors not to be eligible, a Prize is unclaimed after the fourteenth day following the first attempted notification, or a Potential Winner fails to return to *Philadelphia* magazine a signed Affidavit of Eligibility and Liability/Publicity Release as required in Section 5.E, the Sponsors may select an alternate winner at random.
